At 211OC we connect people to the services they need every day of the year. Whether it is access to food, health care, or housing, 211OC can help. We are like the Google of health & human services in Orange County (OC), but better - we make it easier to find the resources that BEST match the person or family's needs. By connecting people with these resources, 211OC helps ensure the well-being of OC's families. People can dial our toll-free number, 2-1-1, and receive referrals from our trained, multilingual specialists 24/7/365, or search for resources online in complete anonymity. 71,961 requests for help were handled via phone, email, and in-person, and we provided over 125,000 referrals during the year; in addition, we helped over 800 households complete

4b (Code: ) (Expenses \$ 855,572. including grants of \$ ) (Revenue \$ 511,421. ) Strategic planning for homeless and chronic issues: 211OC finalized planning to launch the regional program mandated by HUD to coordinate housing people without a home in Orange County - the Coordinated Entry System (CES). This preparation included initial system mapping, bed inventory, data system, as well as lowering barriers to entry into the homeless system of care for those most in need of housing assistance.

4c (Code: ) (Expenses \$ 603,995. including grants of \$ ) (Revenue \$ 361,040. ) Capacity building and providing technical assistance (TA) to other non-profits: provided TA, resulting in increased HUD funding (\$16MM to \$19.5 MM/year) in the OC; the 2nd round of Performance Analysis Report was completed and used to guide program improvements, driving local decision makers to reallocate \$740K+ from low to best performing agencies helping end homelessness; In January 2015 over 700 volunteers deployed to carry out the Biennial Point-In-Time Count of the homeless, collecting data to inform the 2015 report. This Count is required by HUD and helps drive continued funding.
